## **Consultant funding:**

In the meantime a modified guideline for the promotion of entrepreneurial know-how for companies affected by corona has come into force. The amendments to the existing guideline can be found in the Federal Gazette under reference BAnz AT 02.04.2020 B5 and provide for certain simplifications in the course of application. This means that applications can be submitted to the Federal Office of Economics and Export Control (BAFA) for consultations by listed consultants, which are subsidised up to a consultancy value of EUR 4,000.00 for corona-affected small and medium-sized enterprises (SMEs), including freelancers, without own contribution. S&P GmbH Wirtschaftsprüfungsgesellschaft is listed as "consultant" at BAFA.

More detailed information - especially on how to apply - can be found in the information sheet for companies affected by Corona, which is available as well as the online form. In order to avoid risks of subsidy fraud, care must be taken to ensure that the relevant eligibility requirements are met. We will be happy to answer any questions you may have in this context.
